**SUBJECT: Municipal Elections Act – Campaign Financial Reporting
Requirements – FINAL STATUS – Clerks Report**

Pursuant to the requirements of Section 88.23 of the Municipal Elections Act, 1996, the Clerk responsible for the Municipal Election shall make available to the public a report setting out all candidates and third party advertisers in an election and indicate whether they complied with the financial requirements of the *Municipal Elections Act, 1996*. This report must be made publically available and shall be placed on the City's Election website.

The deadline for filing completed Municipal Election Financial Reports for the 2018 Municipal Election was Friday, March 29th at 2:00 p.m. Submissions received by this deadline were as follows:

Candidates:	51 / 57 filed
Third Party Advertisers:	2 / 2 filed

Candidates that failed to submit, and were in default of the requirement, were notified of their opportunity to file a late filing of their financials up until April 29th at 2:00 p.m., with an incurred late filing fee of \$500, in order to not remain in default and be subject to the default provisions outlined below.

Pursuant to Section 88.23(2) of the *Municipal Elections Act, 1996*, Candidates receiving a Notice of Default are subject to:

- a) the candidate forfeits any office to which he or she was elected and the office is deemed to be vacant; and
- b) until the next regular election has taken place, the candidate is ineligible to be elected or appointed to any office to which this Act applies.

The following Candidates failed to meet the financial requirements and until the next regular election has taken place are ineligible for election or appointment to any office for which the *Municipal Elections Act, 1996*, applies:
